Australian British Defence Catalyst 2025 Event

Date: Wednesday 3 September 2025 Venue: Australia House, The Strand, London

Meeting summary:

The Australian British Chamber of Commerce's Defence Catalyst offered the opportunity for the Queensland Delegation to engage with senior UK and Australian Defence and industry leaders who offered their insights on strategic capability development in the face of global geopolitical and trade uncertainty, as well as the sense of urgency created to rapidly improve defence capability as a result of the war in Ukraine which is driving increased development and investment around the rest of Europe. The Catalyst also reinforced the national approach to AUKUS with representatives from a number of State Governments include South Australia, Western Australia, Victoria and Queensland in attendance.

His Excellency the Hon Stephen Smith, Australian High Commissioner to the United Kingdom and co-author of the Australian Defence Strategic Review provided the Australian Government Address. He spoke to the Australian Defence Strategic Review and the UK's Strategic Defence Review and the many parallels and consistencies within them. He also highlighted the alignment of activities in the implementation of the recommendations of both. He commented on the positive economic dividend that is achievable from investment in defence and defence infrastructure and the tangible benefits for local and global supply chains and the communities within which they reside. AUKUS is at the heart of the ongoing strategic partnership between the two nations and he noted the signing of the Geelong Treaty as a bilateral enabler, also welcoming the presence of State Government representatives and acknowledging the important role they play in developing sovereign capabilities.

Mykhailo Federov, First Deputy Prime Minister of Ukraine and Minister of Digital Transformation presented a "Message from Ukraine" with a focus on innovation. Fedorov is responsible for the Brave-One Defence Technology Cluster, which was established in 2023 with a focus on innovation enablers and has included deregulation of the market and the building of an ecosystem inclusive of 2000 companies in defence industry.

Luke Pollard MP, Minister for the Armed Forces; MP for Plymouth, Sutton and Devonport provided the UK Government Address. He acknowledged the significance of the Geelong Treaty and its 50-year time horizon. He outlined the major pillar of the Strategic Defence Review with the UK's focus as "NATO first, but not NATO only" and the implications for continued UK interest and engagement in the Indo Pacific region. The UK will spend an extra 6 billion pounds on defence spending with the intent of reaching 2.5% of GDP by 2027 and rising to 3.5% of GDP by 2035. The Deputy Premier had the opportunity to speak with Minister Pollard directly following his address, discussing the new Queensland Government's commitment to supporting defence industry development and the advanced manufacturing opportunities that may arise through AUKUS Pillar 2.

The overarching themes for the Catalyst conference were:

- the urgent perspective of Ukraine
- the need for interoperability, partnerships, and collaboration in the face of rising global threats
- industry-government cooperation as a genuine "win-win," and the need to change how we deliver
- innovative approaches to strategic investment and the acceleration of capability to the war fighter, and
- the critical challenge of skilled people, and the urgency of finding innovative solutions to recruit, retain, and share talent.









Meeting with UK Minister of State for Rail

Meeting summary:

The Deputy Premier and delegation met with Lord Peter Hendy, the UK Minister of State for Rail. Lord Hendy was the Chair of the 2012 Games Transport Board, which worked with the London 2012 Organising Committee, transport operators, local authorities, and also served as Commissioner of Transport for London (TfL), managing all transport for the Greater-London region. Lord Hendy was also on the Board of the London Legacy Development Corporation (LLDC) until 2024.

The meeting discussed operational planning for London transport which started in detail approximately 2.5 years out from the 2012 Games. A key challenge was managing demand and connectivity consistently across the network and venues. The meeting provided an opportunity to discuss the dual focuses of the IOC on Games outcomes and Host cities focuses on infrastructure legacy outcomes.

The meeting provided an opportunity to hear learnings from London 2012, which included a focus on the functioning of the city during the Games. While the primary point of discussion throughout the meeting was the Games, the discussion also covered the importance of continuing 'business as usual' transport availability for the community in the lead up to, and during the Games.

The Deputy Premier also highlighted key public transport initiatives being undertaken by the Crisafulli Government ahead of the 2032 Games including Cross River Rail, Gold Coast and Logan Faster Rail and The Wave.

Meeting summary:

The Deputy Premier and delegation met with OnePlan, which was engaged by the Paris 2024 Organising Committee during the delivery of the 2024 Games, utilising GIS Mapping and Digital Twin software to plan the Games.

Projects OnePlan supported include:

- Temporary overlay visualisation to assess crowd and traffic managed for key 2024 Games venues
- A VenueTwin (digital twin software) of key Games Venues such which enabled the planning of sports, workforce, infrastructure, security, zones, traffic and more on land and water for efficient Games-time operations

During the meeting a presentation and video were shown of Paris 2024 venues and preparation for the Milano/Cortina 2026 Games.

Paul Foster founded OnePlan, which has been used for over 150 events across many countries, including in Australia.

The meeting provided further insights into OnePlan's partnering with universities to give students an opportunity to work with the technology - students are provided free licences to increase digital capacity and uplift capability.

Mr Foster highlighted the importance of the adoption of digital technology planning for the Games and other infrastructure, for collaboration across the Government, Organising Committee and International Olympic Committee. He also provided advice on requirements to be set out in Games contracts to ensure the required data is collected and available for use in development and operational planning.

The meeting offered valuable insights to technical, security, commercialisation, operational and other aspects of Games planning using digital capability, using real venue data and demonstrating the technology application to previous and future events.



Australian British Defence Catalyst 2025

The Rt Hon Sir Ben Wallace as the former UK Secretary of State for Defence spoke of the strength of the relationship between Australia and the United Kingdom, highlighting also the lessons from Ukraine for government, including the idea of devolving the capability funding to lower levels; to the operational Brigades who can actually develop and achieve capability in very short time frames. He acknowledged that there were examples of significant step changes in spending in Europe citing Germany and Poland as examples. In the context of AUKUS Pillar II, he was an advocate for the UK and Australia continuing to push ahead and jointly develop new capabilities, irrespective of the AUKUS review being undertaken by the new United States Administration.

Andy Bamford spoke of the National Security Strategic Investment Fund (NSSIF) which is a corporate venture capital fund of the Government with a plan for \$100 million of direct investment per year. The work programs are designed to assist in the pull through to contract of R&D work programs with the aspirational aim of an idea to contract being achieved within 10 days. The programs are currently employing 3000 personnel directly. Successful investments are considered not just a fund, but a partnership engine for research to be able to be turned into commercial accelerator programs.

His Excellency the Hon Stephen Smith, Australian High Commissioner to the United Kingdom hosted a Reception for the Catalyst attendees at the Australian High Commission, a semi-formal event where the Deputy Premier was able to meet and have discussions with attendees. Of note he met with:

- Mr Steve Wadey, Group CEO of QinetiQ. They discussed the previous QinetiQ support to the operation of the Queensland Flight Test Range at Cloncurry, innovation, test and evaluation and future opportunities. The Deputy Premier thanked Mr Wadey for supporting his visit to Farnborough in the following days.
- The Rt Hon Lord Spellar, UK Trade and Investment Envoy to Australia. Discussion included Lord Spellar's previous visit to Australia and notably his time with Queensland industry on the Queensland stand at the Avalon Air Show earlier this year. The Deputy Premier offered support to Lord Spellar if planning a future visit to Queensland.
- Major General Hugh Meggitt AM CSC, Head Advanced Strategic Capabilities Accelerator, Australian Defence Force. General Meggitt outlined his organisation and the momentum he is endeavouring to build in innovative capability acquisition. He covered his engagement with Queensland SMEs, universities and the state government support.

Meeting summary:

David Williams as the Permanent Secretary in the Ministry of Defence was involved in the Strategic Defence Review. He spoke of the strength of the relationship between Australia and the United Kingdom. He identified the importance of Pillar II technologies and of the strategic communications around AUKUS with a focus on "getting it right" to partners, investors, allies and communities. He also highlighted the innovation of the SME base and being able to tap into it and into suitable investors.

The Hon Paul Papalia CSC MLA gave an update on the progress and preparations in Western Australia for AUKUS Pillar I. He noted for the UK audience in particular the similarities in capabilities and approach between HMAS Stirling and Faslane in the UK and the Australian Marine Complex Henderson and Devonport UK for the maritime sustainment elements.

The Hon Stephen Mullighan MP spoke of the importance of the development of Osborne for Pillar I and talked of the challenge of generating the 15-30,000 workforce in 15 years, highlighting the re-establishment of the TAFE system, the new Adelaide University and the co-developed Australian Submarine Agency Skills Academy as fundamental enablers.





Meeting with Lord Moynihan

Meeting summary:

The Deputy Premier met with The Right Honourable Lord Colin Moynihan (Lord Moynihan), Member of the House of Lords. Lord Moynihan was a rowing silver medallist, previous Chair of the British Olympic Committee and a Director of the London Organising Committee for the Olympic Games during 2012.

The meeting highlighted the importance of legacy in all planning for the Games and included the sporting legacy for the UK, and school and local community involvement.

Discussion also covered considerations in the London 2012 Budget and the challenges of security planning depending on national and global contextual factors at the time of hosting the Games.

The meeting provided key insights into stakeholder engagement during Games time, between key responsible parties and organisers, requirements of the IOC and the importance of an ambition and focus on legacy outcomes.

The meeting also provided the opportunity to attend a debate on a planning and infrastructure Bill in the House of Lords, as a guest of Lord Moynihan. The Bill covered planning regulation and the protection of sporting infrastructure and open spaces in the United Kingdom. This Bill is relevant to considerations of planning requirements and legacy for 2032. Meeting summary:

QinetiQ was formed in 2001 when the UK Ministry of Defence separated its Defence Evaluation and Research Agency into two functions. QinetiQ was floated on the London Stock Exchange in 2006 and includes a presence in Australia. QinetiQ employs over 8,500 people providing technological and scientific expertise in relation to aircraft, cyber security, asset management, naval architecture and other technologies.

QinetiQ is the UK Ministry of Defence's Strategic Partner for Test and Evaluation and has a long-term agreement to provide T&E and training capabilities through to 2033. QinetiQ operates 16 Test Ranges and facilities in the UK on behalf of the Ministry of Defence with strong connections to University Research and Development programs also.

Key representatives from QinetiQ provided a detailed presentation on their capabilities and role. The meeting included discussion on speed of procurement processes in a rapidly changing global environment. The meeting highlighted the need for focus on more rapid development and testing of technology than has traditionally been the case - required in an evolving and increasingly volatile global environment.

QinetiQ also performs an independent assurer role to the Ministry of Defence where required on new products and technologies.

The Deputy Premier also toured part of the facility to hear about a new technology and view the physical set up of their research area.

This meeting provided an insight into new technologies being developed, how the UK is progressing its defence capabilities and readiness, and provided learnings for Queensland and discussion of key opportunities in the Australian market.

The meeting also covered opportunities for jurisdictions to support Australia's nationally led defence approach. The Deputy Premier emphasised Queensland's willingness to grow the Defence sector locally and provide employment. and growth opportunities - looking for opportunities to partner and apply Queensland's strengths including Queensland's pro-business approach and the Sovereign Industry Development Fund.

Sir Hugh Robertson was a previous British Olympic Association (BOA) Chair and was appointed as a Member of the International Olympic Committee in 2024. He was the Minister for Sport and the Olympics during the London 2012 Games.

It was noted this meeting was as a result of the strong support provided by Australia in previous years - Sydney Games organisers had been willing to share knowledge to benefit the London 2012 Games and is now providing that same support to Brisbane 2032 organisers.

The meeting covered development of Games infrastructure and importance of adequate time for testing of venues prior to the Games. Noted strong support for the Delivery Model approach being pursued by GIICA, as it had proven successful with the London 2012 Games.

The meeting highlighted the housing legacy provided in Stratford and history of the area - regeneration and creation of housing and employment opportunities was a key legacy of the London 2012 Games. Discussed significant infrastructure now provided to a community connected to London - better transport, health, sporting and education infrastructure in an area that had previously experienced significant challenges.

The meeting also included the importance of the relationship with the AOC in the lead up to the Games to ensure a focus on athlete experience and performance.

The briefing also highlighted the opportunity for Brisbane in the lead up to, and after 2032 when the eyes of the world will be on Brisbane and Queensland, being a unique opportunity to showcase Queensland to the world and what it has to offer, ensuring the vision and legacy is clearly defined and unique to the Brisbane 2032 Games.

The meeting provided relevant insights related to Paris 2024 and Los Angeles 2028 - both have unique features and appeal to their local audiences, which will be key for Brisbane.

Also discussed was the importance of community participation in the Games - not just ticketed events, but opportunities for the community to view and participate in the Games and associated events and activations in what is a worldwide event with a local focus.

This included the Urban Park concept, the marathon which gave members of the public the ability to run the same route as Olympic competitors during the Games period, free spectator access to the road race, school education and participation.

Paris 2024 planned to maximise the use of existing and temporary infrastructure. Those temporary venues were set among some of the world's most iconic landmarks, taking sport out of its traditional spaces and bringing it to the heart of the city and communities.

When it came to venue development, the Organising Committee focused on guaranteeing a second life for equipment used, with the majority of recipients identified prior to the Games to leave a lasting legacy.

The meeting also provided information on venue ticketing and transport integration to create seamless spectator experience, supported by volunteers. Volunteer identification and recruitment were discussed, including a focus on training and creation of long-term employment benefits.

Detailed and insightful knowledge was shared on the successful delivery of the most recent Games, at a critical time for the 2032 Games planning, with many venues in the planning and procurement phases.

The Deputy Premier met to discuss Games security operations and potential considerations for the 2032 Olympic and Paralympic Games (2032 Games) based on the Paris 2024 Olympic and Paralympic Games (2024 Games) model with the Prefect of the Paris Police, Mr Laurent Nunez.

The meeting provided valuable learnings for 2032 Games delivery including:

- coordination of security operations across police services and private security providers
- overseeing the implementation of risk mitigation strategies, including counterterrorism, cyber security, and crowd safety
- managing venue security planning, including for high-profile sites and temporary venues
- coordinating with international partners, including the deployment of liaison officers and intelligence-sharing arrangements
- ensuring the integration of transport, emergency services, and public communication systems into the Gamestime security framework.

The meeting provided key insights into the French Government's security coordination model for the 2024 Games, including inter-agency planning and operational delivery; the Queensland delegation was afforded information so that they could understand how the Prefecture managed risks associated with open-air venues, urban transport hubs, and large-scale public gatherings; and identifying opportunities for best practices in security governance, including the role of a central coordinating authority during the Games operational period.

The Deputy Premier and delegation met with Lynette Wood, Australian Ambassador to France, who also hosted a roundtable discussion in relation to infrastructure investment opportunities for key French companies in Queensland's capital pipeline and the 2032 Olympic and Paralympic Games.

The Deputy Premier briefed attendees on the 2032 Delivery Plan, Queensland investment opportunities including the Gabba Entertainment Precinct.

The roundtable event included a number of companies that specialise in infrastructure and transport development or major event delivery, with many involved in delivery of key sites and facilities, or delivery of operations, for the Paris 2024 Olympic and Paralympic Games and the ongoing legacy program.

The Deputy Premier highlighted the opportunity to support future major events, such as the 2032 Games, where they can bring their expertise from Paris 2024, as well as in the \$116.8 billion capital pipeline delivering generational infrastructure across a range of sectors.

The meeting also provided an opportunity to emphasise the work Trade and Investment Queensland is doing with companies in attendance to support their investment interests in Queensland.

The Deputy Premier and delegation met with Detective Superintendent Timothy Jolly, Senior Officer Paris, Australian Federal Police

The AFP Paris Post was opened in November 2023 and a Protocol on Technical and Operational Cooperation was signed with the Police Nationale and Gendarmerie Nationale (the two law main law enforcement institutions in France).

The meeting was an opportunity to hear about how the AFP Paris Post facilitated the deployment of AFP officers to France to support the Paris 2024 Olympic and Paralympic Games. This provided valuable insights into what was a Games first, where the French Government invited law enforcement agencies from some 40 countries, including Australia, to contribute to the Games' security footprint.

The meeting provided shared learnings into the French Government's security coordination model for the Paris 2024 Games, including inter-agency planning and operational delivery, which will be relevant to planning for the 2032 Games, as well as understanding leading practice in security governance and the role of a central coordinating authority during the Games operational period.

The Deputy Premier and delegation met with Flying Whales to understand more about the project and technology, and the potential to establish a presence in Queensland.

Flying Whales is considering the establishment of Flying Whales Services Australia.

Flying Whales was founded in 2012 by Sébastien Bougon and is a French aeronautic start-up developing an airship designed to be an environmentally friendly solution for transporting heavy loads without ground-based infrastructure. The meeting provided an opportunity to discuss and see a presentation about the airships' potential to lift 60 tonnes and support industries such as defence, mining and the movement of housing infrastructure.

It was discussed at the meeting that Flying Whales is backed by the French and Quebec Governments in a Public Private Partnership model and is seeking opportunities for investment from Australia following meetings with the Queensland Government during 2024.

The meeting provided vinformation into an emerging business and technology and provided the opportunity to share the benefits of setting up a business and operations in Queensland, and the Deputy Premier suggested Flying Whales connect with the Department of State Development, Infrastructure and Planning to determine whether they may be eligible to apply for the Sovereign Industry Development Fund

Meeting summary:

The Deputy Premier and delegation met with Ms Marie Barsacq, French Minister for Sport. The Minister was appointed to her current position on 24 December 2024, following a career in sport governance and development, including having previously served as Executive Director for Impact and Legacy on the Paris 2024 Organising Committee.

The meeting provided insights into the French Government's approach to sport policy and legacy planning for the 2024 Olympic and Paralympic Games, as well as how national sport initiatives, such as Génération 2024 and Impact 2024, were integrated into Games delivery and community engagement.

Information shared included opportunities for collaboration on inclusive sport access, youth engagement, and physical activity promotion, particularly in relation to the Crisafulli Government's Games On! Program.

The Ministry of Sports, Youth and Community Life (the Ministry) is responsible for national policy on sport, youth engagement, physical activity, and community development. The Ministry played a central role in the delivery and legacy planning of the 2024 Olympic and Paralympic Games, working alongside the Paris 2024 Organising Committee and Solideo, the French Olympic delivery authority. Key initiatives for the 2024 Games included:

- coordinating the national sport strategy to ensure Games infrastructure aligned with long-term community and elite sport goals.
- supporting the development of high-performance venues and local sport infrastructure across France.
- leading the rollout of 30 minutes of daily physical activity in schools, now embedded in national education policy.
- administering the Génération 2024 label (now Génération 2030) to promote Olympic values in schools and youth programs.
- overseeing the Impact 2024 fund, which financed over 1,000 community sport and inclusion projects.
- facilitating the reopening of the Seine and Marne rivers for public swimming, a key environmental legacy of the Games.
- promoting inclusive sport access, with increased participation from people with disabilities and traditionally underrepresented groups.

Meeting summary:

The Deputy Premier and team met with GL Events to discuss their experience supporting the Paris 2024 Games as operators of Stade de France and also to share information on the progress of the delivery of the 2032 Games.

Representatives also attended a site visit of the Stade de France venue, used for the 2024 Games, to discuss GL Events' involvement in operational support for the 2024 Games.

The meeting provided an opportunity to tour Stade de France, France's largest stadium, located in Saint-Denis, which was upgraded to host athletics events. The upgrades included improved spectator experience, enhanced energy efficiency, and modernised lighting and screen system. The meeting also provided a valuable opportunity to hear about the investments made in transport infrastructure, including the extension of Metro Line 14, improving northsouth connectivity as well as other transport linkages to the venue, a subject relevant to 2032 Games planning involving upgrade of existing venues and development of new transport infrastructure in time for the Games.

GL Events provided detail on their engagement by the Paris 2024 Organising Committee as an official partner and overlay provider for the 2024 Games, which involved providing products and services relating to the planning, design, supply, installation and on-site integration of multi-purpose structures, interior fixtures and fittings, grandstand seating, broadcast lighting, rigging and scaffolding.

GL Events has also recently been awarded a 30-year concession by the French government to operate the Stade de France, and so the meeting was an opportunity to hear from an international venue operator about management, operations and venue maintenance.

Meeting summary:

The Deputy Premier and team attended a networking reception, hosted by Ms Lynette Wood, Australian Ambassador to France, to celebrate the cultural connections between France and Australia, including those activities supported by the Australia-France Roadmap.

The Roadmap commits Australia and France to establishing a French-Australia cultural exchange foundation/initiative in both Australia and France focused on developing ties between arts and culture institutions, particularly through artistic residence programs.

In 2023, Australia and France signed a Declaration of Intent (DoI) to increase sporting cooperation. The DoI is focused on sharing best practice in organising major sporting events, reducing the environmental impacts of sporting infrastructure and promoting the sports industry in both nations, which is important in the lead up to the 2027 Men's and 2029 Women's Rugby World Cup in Australia, and the Brisbane 2032 Olympic and Paralympic Games.

France and Australia also committed sharing expertise on sports science and research, ethics, anti-doping and corruption, training and coaching, and the promotion of women's sports and parasports.

The reception was attended by approximately 50 representatives from the arts and culture sectors, as well as key stakeholders from the French Government, including Mr Pierre-André Imbert, Ambassador of France to Australia.

Meeting summary:

The Deputy Premier met with Artelia which provides development and construction services across design, project management and asset management services covering the entire life cycle of assets. Artelia is one of Europe's top 15 construction engineering companies and provides customers with a network of agencies and subsidiaries. The Group is present in 40 countries in Europe, Africa, the Middle East, Asia-Pacific and America.

The Village hosted 14,500 athletes during the Olympics and 9,000 during the Paralympics. The Village was designed for conversion into housing units, offices, and community facilities post-Games. Almost 40 per cent of this accommodation is set to be turned into social housing.

Artelia provided project management for the construction phase of the Athletes Village (over 30,000 m² of floor space) and the refurbishment of the Maxell Hall, which served as a support building (polyclinic, fitness centre, information centre) during the 2024 Games.

Artelia hosted a site tour of the Games village, demonstrating the ongoing process of conversion from Games mode to legacy use. The tour also highlighted spaces used for temporary Games overlay, including the transport hub, as well as consideration of security requirements and athlete experience.

Meeting summary:

The Deputy Premier and delegation met with the CEO of SOLIDEO, which was established by the French Government in 2017 as the public authority responsible for financing, supervising, and delivering all permanent infrastructure required for the 2024 Games. SOLIDEO's remit for the 2024 Games included:

- direct oversight of major Olympic construction projects, such as the Athletes Village, Aquatics Centre, and Media
- supervision of execution for additional Olympic and Paralympic works, including upgrades to existing venues and public realm improvements.

SOLIDEO's program budget was financed by public and private-sector appropriations. With a Board of 38 Directors, SOLIDEO was overseen jointly by the Minister for Public Action and Public Accounts, the Minister for Local Authority Relations and the Minister for Sports. Discussions included SOLIDEO's operating model which includes:

- a centralised delivery authority with legislative backing.
- close coordination with the Paris 2024 Organising Committee, local governments, and private sector partners.
- use of planning law exemptions to accelerate delivery of Venue projects in time for the 2024 Games.

The meeting enabled sharing of information on SOLIDEO's approach to Games and legacy planning, including the conversion of Games venues into community assets.

Following the Games, SOLIDEO is looking ahead to this new stage, which is essential to the full achievement of the Olympic and Paralympic project, to ensure the lasting legacy of the Games for the benefit of the regions.

The Deputy Premier and delegation met at the Adidas Arena in Paris for a site tour. The Adidas Arena, located at Porte de la Chapelle in Paris, was constructed as a new venue for the 2024 Games hosting a range of events. Post-Games, the Adidas Arena has been repurposed as a legacy venue for cultural events and is the home of Paris Basketball Club.

The meeting noted the range of services Egis offers including consultancy, design and engineering. This included services to support venues for Paris 2024. Egis is currently engaged in the modernisation of 16km of critical roadway (RD1091) in France to support the 2030 Winter Olympic Games.

The Australian Olympic Committee (AOC) has also appointed Egis as engineering consultants and infrastructure operators through to 2026.

The meeting provided a valuable opportunity to visit the newly constructed Arena venue, which was in the midst of set up for a sporting event. This tour provided important insights into Arena venue construction, operation and maintenance relevant to Queensland's plans for the Gabba Entertainment Precinct and Sunshine Coast Arena/convention centre which are in the planning stages.
